Community News

We had an increase in Deed Restriction violations in 2022.
Be sure to review yours on our website.

For yard, trash, and animal issues, we recommend that neighbors be notified first of any problems. Sometimes a friendly conversation solves the situation. If the violation has not been addressed after 7-10 days, then we recommend filing a report with the appropriate City of Houston (COH) department by dialing 311. While slow, the COH service is free, they do address the reported issues, and any neighbor is able to utilize their services.

Did You Know?

OE property owners are required to submit renovation/construction plans to the ACC prior to beginning work on a property. Doing so can save neighbors time and prevent costly issues.

- A. First, the owner shall submit a preliminary design. This submission shall reflect the site plan, roof plan, floor plan, all elevations, and further improvements and shall be drawn (free hand or otherwise) to a generally accepted architectural scale. The action of the architectural control committee at this stage of submission shall be deemed advisory only. *[At this point the ACC can advise if further review is necessary.]*
- B. Second, the owner shall submit for review by the architectural control committee a full set of final detailed construction plans and specifications which must include, but is not necessarily limited to: (i) a site plan reflecting the location and dimensions or boundaries of alt easements, lot lines, setback lines, foundations (with elevations), walks, drives, fences, and any other improvements to be located thereon; (ii) foundation plan (iii) floor plan; (iv) exterior elevations; (v) framing sections; and (vi) materials list.

Hidden White Bean Tomato Soup

Trying to incorporate more veggies into your New Year? Try this simple yet delicious soup recipe perfect for cold weather.

Prep Time 5 mins **Cook Time** 45 mins **Blending time** 5 mins

Servings 6 **Calories** 112.9 **Author** Carleigh, PlantYou



Equipment

- Knife, chopping board, roasting pan, pot, immersion blender or regular blender

Ingredients

- 6 vine ripened tomatoes cut in half
- 1 1/2 cup cherry tomatoes
- 2 heads garlic, tops sliced off
- 1/2 cup fresh basil
- 1 red bell pepper diced
- 1 1/2 cups white kidney beans canned, drained & rinsed
- 2 tbsp olive oil
- 1 tbsp dried parsley
- 2 cups vegetable broth
- 1 tbsp nutritional yeast, or a cheese of your choice
- salt and pepper to taste

Instructions

1. Preheat the oven to 375F.
2. Coat a cast iron pan with oil of choice. Add all listed ingredients apart from the broth and nutritional yeast to the pan.
3. Place in the oven for 45 minutes, until the vegetables have softened.
4. Remove from oven and allow to cool slightly. Using your hands, squeeze out the garlic into the pan and discard the skin.
5. Pour vegetable mix into a pot with the broth and nutritional yeast and using an immersion blender combine until smooth. If using a regular blender, be **extremely careful** of the heat when pouring and blending!
6. Enjoy immediately!



CIVIC CLUB VS HOMEOWNERS ASSOCIATION

What is a Civic Association?

Outpost Estates has a Civic Association (CA) which is a non-profit organization whose primary goal is to improve the quality of life in a given neighborhood through volunteer work by its members. The CA keeps up with important issues affecting the members in a neighborhood (i.e. land-use planning, improvement of infrastructure, traffic management, public safety and crime, etc.) and acts as a liaison with city agencies. Membership is voluntary. Dues are used to coordinate community events.

What is a Homeowners' Association?

A Homeowners' Association (HOA) is a non-stock corporation formed by a real estate developer for the purpose of marketing, managing, and selling lots and homes in a certain subdivision. It grants the developer control in governing the association until a certain amount of lots or homes are sold in the development. When that number of lots or homes are sold, the developer transfers legal responsibility of the organization. Membership in the HOA is mandatory; it is a condition of purchase. Dues are also mandatory. The dues are used to maintain and operate certain common areas throughout the neighborhood. Typically, there are covenants and restrictions which all members must follow.
